**CRESCAT, DELPHI TO FUND ADDITIONAL DRILLING  
AT PACIFIC RIDGE'S KLIYUL COPPER-GOLD PROJECT**

**Vancouver, B.C. – September 4, 2022** - Pacific Ridge Exploration Ltd. (PEX: TSX Venture) ("**Pacific Ridge**" or the "**Company**") plans to increase the size of the previously announced non-brokered private placement (see news release dated September 2, 2022) by 1,000,000 units to 3,391,305 units at a price of \$0.23 per unit ("**Unit**") for gross proceeds of up to \$780,000 (the "**Financing**"). DELPHI Unternehmensberatung Aktiengesellschaft, Pacific Ridge's second largest shareholder, intends to acquire the additional 1,000,000 Units. Crescat Capital LLC, the Company's largest shareholder, intends to acquire the remaining 2,391,305 Units.

Proceeds from this Financing will be used for additional drilling at the Kliyul copper-gold project, located in northcentral B.C., and for general working capital.

Each Unit will be comprised of one common share of the Company and one-half of one common share purchase warrant, with each whole warrant exercisable to purchase one additional common share at an exercise price of \$0.35 for a period of 2 years. The Financing is subject to TSX Venture Exchange acceptance.
